- 2. Leave of Absence was granted to absentee members.
- 3. The Minutes of the previous Governing Body Meeting held on 17th October, 2016 was reviewed and approved.
- 4. As per UGC guidelines Modified CBCS and OBE (Outcome Based Education) is introduced from the academic year 2017 onwards. To extent the learning outcomes of individual student Modular System, Capstone Model of Evaluation and Skill based curriculum has been introduced. The Governing Body appreciated new approach taken by our Institution and approved it.
- 5. The Principal informed the members that the College has been ranked 22nd in All India among arts and science colleges by NIRF of MHRD to the year 2017. It is to be noted that the College is ranked as Number 1 in All India under Self Finance Colleges.
- 6. The Principal presented the report on activities during the last one year. The report includes
 - a. The total strength of the College for the academic year 2017-2018 is 6943.
 - b. The Admission for the academic year 2017-2018 is 2673.
 - c. The number of placements for the year 2016-2017 is 1182 with the offer of 1837.
 - d. In 2017-18, till 26.10.17 19 leading MNC companies offered 261 offers with salary range 1.44 Lakhs to 4.56 Lakhs per annum.
 - e. The details of the papers published and presented in various National/ International Conferences and Seminars by the faculty and students were presented.

- 11. The College has signed MoU with Clayton State University, Atlanta, USA. According to this tie-up, the BBA Students study first 2 years in our college and 3rd and 4th year at Clayton State University, Atlanta, USA. Students will be awarded BBA degree by Clayton University. After studying 1 more year at USA, they are qualified for MBA degree in Management. Further, faculty can be engaged in research jointly. The Governing Body congratulated and approved the same.
- 12. The College has signed MoU with Concordia College, New York. According to this tie-up, the B.Com students study first 2 years in our college and next one year at Concordia College, New York. Students will be awarded B.Com degree by Concordia College, New York.
- 13. Concordia also offers summer classes for SKASC students and students will get 2 additional credits in their curriculum. They also offer Faculty exchange programmes and collaborative research. The Governing Body congratulated and approved the same.
- 14. The committee members had a detailed discussion on starting of new courses from the year 2018-2019. It has been decided to apply to Bharathiar University for starting/recognition of the following courses:
