- The committee recorded the minutes of the previous Governing Body meeting held on 25th
 Oct 2019 and the action taken based on the suggestions given in the meeting. The minutes
 and the action taken were approved.
- The Chairperson requested the principal to present a report on the activities in the college from the last Governing Body meeting to till date.
- 5. The Principal presented the report and the highlights as follows
 - a. The present strength of the college is 8281 and the faculty strength is 301.
 - b. During the academic year 2019-20, 2377 students got placed in various multinational and National level companies with a total offer of 2575. The highest salary being 6 lakhs per annum and an average salary is 3.2 lakhs per annum.
 - c. During the academic year 2020-21 to till date, 25 companies visited the college for placement and 721 offers have been received by the students. The highest salary being 5.76 lakhs per annum.
 - d. The Principal announced that the college has improved its National ranking during the year 2019-20 both in NIRF and in Media.
