

General Suggestions:

- Dr. K. Sangeetha, University Representative, , raised a query regarding the initiatives of the Anti-Drug Awareness Club and the activities undertaken by the College in this regard. The Principal informed the Council that the Anti-Drug Club has organized over 40 awareness events for students so far. She also enquired about the implementation of the Police Akka Scheme, to which the Principal responded that the College conducts Police Akka programmes each semester.

She sought clarification on how students are motivated to pursue higher education. The Principal explained that the Career Guidance Cell regularly organizes programmes to help students identify their career pathways and pursue higher studies accordingly.

Addressing the Catering Science Board, she raised a question regarding the inclusion of Indian Cooking Systems in the curriculum. Mr. Sathish, Head of the Department of CSHM, responded that the curriculum already incorporates traditional cuisines from various Indian states. She further suggested undertaking research on millets, traditional millet-based practices, and indigenous methods of preparation and she suggested mapping the curriculum with the UN Sustainable Development Goals (SDGs). The Principal confirmed that the College is already implementing SDG mapping across courses.

She also proposed observing a “No Engine Day” by conducting online or blended classes for staff and students, enabling them to work from home in support of the SDGs. The Principal replied that a similar model had already been implemented in the previous semester.

- Dr. Chitra, University Representative, appreciated the Management, Principal, CoE, Deans, Heads, and faculty members for their collective efforts. She enquired whether the Languages Board had published any books. The Dean of Languages informed the Council that 2 books been published and one book publication is currently in progress. She also asked whether the College publishes a newsletter, to which the Principal responded that the institution releases a newsletter titled “SKASC BEATS.”
