1. The meeting commenced at 10:00 AM with a welcome note by the Chairperson, Mrs. S. Malarvizhi.
2. Dr. R. K. Chauhan, Mr. S. Durairaj, Mr. Mahendra Ramdas and Mr. K. Raghavendra expressed their inability to attend the meeting and requested for Leave of Absence and it has been recorded.
3. The Minutes of the previous Governing Body Meeting held on 27th June, 2015 was reviewed. The proposal was accepted by all the members and minutes were approved.
4. The Principal presented the report on the academic activities during the last five months. The report includes
 - a. The total strength of the College for the academic year 2015-2016 is 5458.
 - b. The Admission for the academic year 2015-2016 is 2018.
 - c. In 2015-16, till 15.10.15 eight leading MNC companies offered 434 offers.
 - d. The details of the papers published and presented in various National and International Conferences and Seminars by the faculty and students were presented.

5. The ratification of appointments and resignation of the faculties was presented from the last meeting to till date for approval. The Governing Body approved the same.
6. The Minutes of the Meeting of Statutory and Non-Statutory Committees held during June 2015 to till date were reviewed. The Governing Body approved the minutes of the various committees.

7. The committee members had a detailed discussion on starting of new courses from the year 2016-2017. It has been decided to apply to Bharathiar University for starting of the following three new courses:

1. B.Com with Accounting and Finance (Additional Section)
2. B.Voc. in Information Technology
3. B.Voc. in Telecommunications

The College has already applied to UGC for two B.Voc. Programmes after getting no objection certificate from the Bharathiar University and is awaiting orders from UGC.

8. Dr.P.Kolandivelu, University nominee suggested that the Citation Index may be considered for Research articles in Science (rather than impact factor) and the members approved this.

9. The Chairperson suggested that the next governing body may be held in March 2016.

10. As there was no other points for discussion, the meeting came to close with the Vote of thanks by Secretary.
