- The meeting commenced at 11:00 AM with a welcome note by the Chairperson, Mrs. S. Malarvizhi.
- 2. Leave of Absence was granted to absentee members.
- 3. The Minutes of the previous Governing Body Meeting held on 26th October, 2017 was reviewed and approved.
- 4. Sub: Appointment of Principal for Sri Krishna Arts and Science College. The Chairperson and Managing Trustee Mrs. S.
