- The general body ratified the appointment of 44 faculty members based on the sanctioned workload and the body also ratified the resignation of 41 faculty members from the last meeting to till date.
- The Principal also placed on record the minutes of Academic Council, Board of Studies, Statutory and Non – Statutory Committee meetings under autonomous Scheme held during this period.
 The committee recorded the minutes.
- The Principal also presented the results of the Odd Semester Examination held during February/March 2022 which was conducted through online mode.
 The results were recorded.
- As a part of OBE implementation, the college has introduced revised OBE guidelines (Learning Outcome Curriculum Framework Model) from the academic year 2021-2022 for the students admitted were approved.
- The College has planned to conduct Internal Audit in May 2022 and External Audit in June 2022.
- The Value Added Courses policy was presented for the academic year and by approved. New Value Added Courses were presented to be offered each department.

- Covid Special Welfare measure given by the management for students, faculty and community was recorded.
- The Outreach Programmes conducted by NSS,NCC,YRC and other clubs on Social Awareness, Health and Hygiene, Cleaning Environment Activities were presented and recorded.
- A Feedback mechanism was detailed by the Principal. The Mechanism involves
 collecting feedback from students, parents, alumni, industry HR people and subject
 experts about the curriculum, teaching learning methodology, evaluation, placements
 and other facilities. The responses were interpreted statistically and the action taken
 report was recorded.
- The report on the strategic future plan and the road map of the college. Implementation of NEP, Extension of Autonomy, Academic Bank of Credits (ABC), Increase Number of Patents and Publications, provide more placement opportunities, establish collaborations with industries and inculcate startup and entrepreneurship culture were placed and recorded.
- Dr.R.Ulagi suggested to include sports achievements.
- Dr.N.Jeyakumar suggested to appoint patent Directors, Research Directors & link funding for developed patent, new efforts in academic and research level should be increased. New courses with AI, Data Analytics, IOT - Commerce with IOT, Data Analytics can be introduced. And also he suggested to have Inter disciplinary research, one research centre for both funding, fellowship, summer projects.
- Mr.Nandha Kumar insisted Industry, institutions interaction should be increased.

- Mr.Jayakumar Ramdass insisted sports achievement should be increased, Evaluation of faculties need a new approach, overall metrics in evaluation should be added for the faculty evaluation, patents should come through as products. In the report correlate academic achievements, attitude, skills, medium students excelling in other activities. Industry, Cattle rearing places, real world training, finishing School and Hands on training in the industry should be arranged for the students. Scholarship should be increased, alumni association scholarship should be initiated, Alumni corpus fund for helping a students, academic & skill oriented activities should be given importance.
- The Principal presented the report of AQAR and informed that the committee the AQAR report of academic year 2020 - 2021 will be submitted on or before May 15th 2022.
- The Chairperson suggested that the next Governing Body meeting will be held in September/October 2022.
