Events conducted(3)

1. Lecture on Consumer Protection Act, 2019

Date: November 16, 2021

Participants: 81 Highlights:

The session featured a keynote address by MFJ Lion Advocate Mr. M. Madhivanan, who discussed the salient features of the Consumer Protection Act, 2019, which repealed and replaced the previous 1986 Act. Key topics included:

- The rules framed under the Act in 2020.
- The importance of consumer awareness in society and culture.
- The fundamental rights enunciated in the Indian Constitution and their connection to consumer rights.



2. Commemoration of National Consumer Day

Date: December 24, 2021

Participants: 89

Highlights:

National Consumer Day is celebrated on December 24 each year to commemorate the enactment of the Consumer Protection Act in 1986. The event aimed to raise awareness about consumer rights and responsibilities. Key highlights included:

- The establishment of the Central Consumer Protection Authority (CCPA) under the 2019 Act to promote and enforce consumer rights.
- A speech by Chief Guest Mr. S. Mohan Babu, Taluk Supply Officer, Deputy Thasildhar, Perur, Coimbatore, who emphasized the significance of consumer education.



3. Commemoration of National Consumer Day - Competition

Date: December 24, 2021

Participants: 35 Highlights:

This event featured an essay writing and drawing competition for students in classes 6 to 8 from Government High School, Gandhimanagar, Peelamedu, Coimbatore. The competition focused on the theme "Tackling Plastic Pollution." Highlights included:

- Participants incorporated recent announcements by CM M.K. Stalin and relevant surveys in their essays, showcasing their engagement with current events.
- The drawing competition allowed students to creatively express innovative ideas on reusing plastics and reducing plastic usage.

The Chief Guest for this event was Mrs. G.K. Vijayalakshmi, Head Mistress of the Government High School, who praised the students for their creative talents.

Date: November 22, 2022

Participants: 106

Highlights:

The session featured a keynote address by MFJ Lion Advocate Mr. M. Madhivanan, who provided valuable insights into consumer protection. Key topics discussed included:

- Role of Social Workers: Mr. Madhivanan emphasized the critical role social workers play in advocating for consumer rights, both socially and legally. He illustrated how social workers can help individuals navigate consumer-related issues.
- Standardization of Products: The speaker highlighted the importance of standardization across industries to ensure product safety and reliability. He explained that standardization aims to establish uniform practices within the industry, focusing on the creation process, operational methods, and technological use. An example cited was the Bureau of Indian Standards (BIS) 916 marking for gold and related products, which ensures quality and safety for consumers.
- Consumer Awareness: Mr. Madhivanan stressed the necessity for consumers to be aware of their rights and available remedies, especially in the rapidly evolving

e-commerce landscape. He underscored the risks associated with online shopping and the importance of being informed to protect oneself against unfair practices.


4. Commemoration of World Consumer Rights Day – Orientation Visit to District Redressal Forum
