Sri Krishna Arts and Science College was established in the year 1997 and granted affiliation by the Bharathiar University. During the past 25 years he college has introduced many disciplines in Arts, Literature, Science, Commerce and Management Programmes. In the year 2011 the College was granted Autonomous status by the University Grants Commission, under the Autonomous status the college introduced more disciplines of study under Choice Based Credit System. The College designed its curriculum in a modular system which helped the students to choose their subject of study as per their aspirations. The Choice Based Credit System introduced by the college has resulted in truly multi-disciplinary education in Arts, Literature, Science, Commerce and Management discipline. The following are the disciplines which are being taught at present are Arts and Humanities, Literature, Basic Sciences, Applied Sciences, Computing Sciences, Commerce and Management Sciences.

**Multi-disciplinary approach**

The curriculum designed by the College under the flexible Choice Based Credit System adopt a multi-disciplinary approach within the curriculum. Each Under Graduate program is designed in 9 modules. Among the 9 modules, 4 modules represent the core discipline and the rest 5 modules are multi-disciplinary in nature. The Multi-disciplinary modules include multi-Indian languages, skill enhancement courses, general elective courses, non-credit courses and additional credit courses.

The Choice Based Credit System under Multi-disciplinary provides a cafeteria type approach in which students can take courses of their choice, learning at their own pace, undergo additional courses, acquire more than required credits and adopt interdisciplinary approach to learning. Thus, the Choice Based Credit System make the product of the college at par with the global practices in terms of academic standards and evaluation strategies, retaining the present structure of the Under Graduate and Post Graduate Programmes. In the emerging scenario of internalization of Indian higher education, it is imperative that Universities and Affiliated Colleges in India should follow the systems that the mobility of the product both within and across, the geographical jurisdiction becomes possible. Hence the college when it becomes the deemed to be University plan to introduce other disciplines namely, Computer Science and Engineering, Engineering Sciences, Special Education, Legal Studies along with the existing discipline namely Arts and Humanities, Literature, Basic Sciences, Applied Sciences, Computing Sciences, Commerce and Management Sciences. While adding New programs to the existing discipline it is proposed to add new disciplines with innovative programs over the period of next 15 years. It is again proposed to establish 11 faculties with 26 Schools which is outline in its vision document 2040.
